- **1995** Built a 4-plex to provide affordable and accessible housing
- Formal name change from Frontier
  Training Center to Frontier Community
  Services
- Built a community home in Valdez for individuals moving out of a State run institution
- **2000** Expanded services to include the Fetal Alcohol Spectrum Disorder (FASD) program
- **2005** Awarded the Behavioral Health/ Independent Case Management Grant
- **2005** Held the first annual World Series Baseball Event
- 2007 Was awarded the Supported Employment Grant
- 2009 Added the Forget-Me-Not Adult Day Center
- 2011 Began offering Infant Mental Health Services
- **2012** Was nationally accredited through the Council on Accreditation (COA)
- **2012** Expanded services to include the Family Support Services Grant

## What is Frontier Community Services all about?

#### **What We Provide**

Frontier Community Services currently has 14 programs that provide services to individuals and their families ranging from birth through the end of life. Qualifying infants, toddlers, children, adults, and seniors can be served by the agency through one or more of the following programs:

- Infant Learning Program (birth-3)
- Developmental Clinic (birth-adult)
- Developmental Disabilities (toddler-adult)
- Family Support Program (birth to age 12)
- Fetal Alcohol Spectrum Disorder Clinic (birth-adult)
- Forget-Me-Not Day Center (Seniors 60 and over)
- Senior In-Home Grant (Seniors 60 and over)
- Day Habilitation is centerbased and in the Community (all ages)
- Vocational Training (adults)
- Supported Employment (adults)
- Behavioral Wellness Program (adults)
- Nursing Oversight (adults)
- Group Living/Residential (adults)
- Home and Community Based Waivers (infants to seniors)

In addition, we provide services that include pediatric occupational, physical and speech therapy, and play therapy which is offered by a licensed Child and Family Therapist.


## What would my job as Board Member be?

In your role as a board member, you will have three primary functions;

- setting policy and direction for the agency,
- 2) fiscal oversight, and
- 3) hiring and evaluating the executive director.

The Frontier Community Services Board of Directors meets the second Monday of every month. All board meetings are conducted in the boardroom at Frontier Community Services' main administrative building located at 43335 K-Beach Road, #36 in Soldotna, Alaska.

Members are asked to serve for 3 years and can be nominated for an additional term by the board.



#### Who We Serve

Services are provided to approximately 500 individuals annually that range from birth to end of life that experience a disability or are at risk of experience a disability.

## How Do I Become a Board Member?

To be eligible to serve on the Frontier Community Services' (FCS) Board of Directors, you must be over the age of eighteen, not an employee or spouse of an employee of FCS and must be a member of the communities FCS serves. Board members are sought who have expertise in governance, financial management, fundraising, and disability service delivery.

## Can I serve on a committee without being a Board Member?

**YESI** FCS has 3 committees: Policy & Procedure and Board Development Committee, Events Committee, and the Finance Committee. The groups meet quarterly and report back to the Board Members on specific topics. Serving as a committee member is a wonderful way to contribute your specific knowledge and skills to the agency.

#### **Expectations**

- Attend nine (9) board meetings per year
- Participate in the board's annual planning meeting
- Participate in at least one board training and at least one FCS community event annually
- Serve on one board committee (standing or ad hoc)
- Hold the agency to a high standard of performance and to actively help make this a quality organization
